THREE MAIN TYPES OF PROBATE:



MINERAL PROBATE

When mineral interests are involved.



ANCILLARY PROBATE

When property is located outside the home state.



FULL PROBATE

When the complete estate requires court administration.

Estates that are primarily made up of mineral assets.

Out-of-state residents who owned property in North Dakota

Estates with diverse assets that don't qualify for simplified probate.
